

Colorado Restaurant Foundation Angel Relief Fund Expands to Cover Mental Health Care

Restaurant and hospitality industry employees can apply for grants of up to \$1,000 to cover the cost of mental health treatment.

Denver, CO – May is Mental Health Awareness Month, and the **Colorado Restaurant Foundation (CRF)** is thrilled to announce a newly expanded scope for its **Angel Relief Fund**, which has been providing emergency grants since 2019 to Colorado restaurant workers experiencing hardship. The expansion of the program will allow industry employees to apply for grants of up to \$1,000 for mental health care, which will be paid directly to their mental health-care provider.

Once approved, applicants and their providers can submit invoices to the CRF for reimbursement. All information will be kept confidential, and invoices may be redacted; the CRF will not ask for diagnosis information to protect the privacy of grant recipients.

The CRF is kicking off this grant program by partnering with two providers -- **Khesed Wellness** and **Teladoc** -- to make it easy for applicants to find the counseling they need; applicants can also choose a different provider, as long as certain criteria are met. Those criteria are listed on the <u>Angel Relief Fund</u> <u>Mental Health Care Grant Application</u>.

Khesed Wellness (khesedwellness.com) specializes in providing affordable outpatient mental health and wellness services, with a particular focus on serving restaurant industry employees. Teladoc (teladoc.com) provides virtual health care services via phone and video conferencing.

"The restaurant industry offers rewarding careers in a supportive environment, but like nearly every industry during the pandemic, employees have suffered from additional stress and difficulty," says CRF president Laura Shunk. "We want to recognize the pandemic-related toll on the mental wellbeing of people working on the front lines at restaurants and other hospitality jobs by providing relief funds for much-needed professional services."

In addition to the expansion of the Angel Relief Fund, the CRF has also rolled out a new Health & Wellness Resource Center (<u>https://corestaurant.org/foundation/health-wellness</u>) to provide industry employees ongoing support. The Resource Center not only compiles a wide variety of available assistance programs, from crisis support lines to industry-specific support groups like CHOW (chowco.org), but it also links community members to up-to-date classes and other events related to health and wellness.

The first of these is a free mental-health webinar hosted by Khesed Wellness. **It's Not Just You: Navigating Mental Health in the Industry** takes place via Zoom from 11 a.m. to noon on Tuesday, May 24, 2022.
